

Vistoso Community Association Compliance Committee Meeting – May 10, 2022 Zoom Platform - GENERAL SESSION MINUTES

- The meeting was called to order at approximately 3:02pm. The Committee Chair, Carl Buchwald was present; as well as Ray Gans, Sheryl Forte, Kim Roessler, Sharon Rodriguez and Terry Campbell. Present from FirstService Residential was Joe Watson Compliance Coordinator and Barbara Daoust General Manager.
- Adopt Revised Agenda: A motion to approve the agenda as presented was made by Carl Buchwald, seconded by Ray Gans. Motion carried unanimously.
- Approval of April 12, 2022, General Session Minutes Ray Gans moves to approve April 12, 2022, Minutes, seconded by Sheryl Forte. Motion carried unanimously.

- Homeowner Hearing:

Milbrae Springs: Owner requests that the pool backwashing fine be waived. Owner explained that the backwash pipe was installed by the previous homeowner prior to her moving in over 20 years ago. Owner stated that pool is not in use and the backwash pipe had been removed. Photos were presented that shows the backwash pipe is removed. Owner also stated that the erosion was caused by past monsoon rains. When it rains heavily, the water comes over the back wall into her yard, and it also flows on the desert side of the wall to the street. There was discussion for a request for a follow-up report from AAA Landscaping on erosion damage and a bid for possible wall repair. A motion was made by Carl Buchwald to approve the recommendation to the Board of Directors to fine the property. The motion was seconded by Sheryl Forte. Motion carried unanimously.
