• Irrigation and lighting have been completed at the Tangerine Monuments.

- Continuously spraying weeds across VCA and started pre-emergent on August 8th.
- Crews addressed clearing the roadways & sidewalks of broken limbs from recent storms
- No major storm damage has been reported since the last occurrence.
- Scalping to begin mid-September with seeding to begin end of September.
