- Irrigation to the turf has been reduced to 2x times a day and will be reduced to 1x in coming weeks. Technicians have adjusted drip values to accommodate cooler weather.
- Spray Technicians addressing damage caused by Javelinas throughout VCA areas. Most affected areas are Hohokam Park, Torreno East Park and Sunset Park.

- Hohokam Park Curb Replenishment was completed on October 18<sup>th</sup>.
- Moore Loop Dog Park Erosion Repair completed on October 16<sup>th</sup>.
