Anything which is not already identified within the Design Guidelines may still be submitted for, but please allow 30-days for processing. Anything which would require a variance from any of the governing documents may be submitted for, but will also require 30-days for processing.**

**If you are submitting to repaint your home, administrative approvals are easily obtained, as long as you are using colors from the approved paint palette within the community. Colors not in the currently approved paint scheme & palette will be sent forward to the ARC for review. This committee is made up of owner volunteers and they review all projects against the Design Guidelines for Common Projects.**

**When this form is filled out, and all information is included, submit it to the staff at Vistoso Community Association/ FirstService Residential. You can email the form, drop off or mail the form to the on-site office at 945 W Vistoso Highlands Dr, Oro Valley, AZ, 85755. Architectural Review Committee requests will be reviewed as soon as possible. Timelines are in direct proportion to the project you have submitted varying from 7-days to 30-days. Your request may be approved quickly if you supply all the information needed for a quick turnaround. Requests will be approved, denied or returned for additional information after review.
